

Please read these notes before you fill in the form

Your Council Tax bill assumes there are at least two adults living in your home. If only one adult lives in a property, we can reduce the Council Tax by 25%.

Some people are not counted as living in a property for Council Tax purposes, so even if there is more than one adult living in your home, you could still get a discount.

We do not count people who are **on remand** or **in prison** as living in your home for Council Tax purposes.

By 'on remand or in prison' we mean a person:

- Detained in a prison, hospital or any other place by a court order in the UK, or a standing civilian court established under the Armed Forces Act 2006; or
- Detained awaiting deportation under the Immigration Act 1971; or
- Detained in a place of safety under the Mental Health Act 1983.

We will still count someone as living in a property for Council Tax purposes if they are detained for the non-payment of fines, Business Rates, Community Charge (Poll Tax) or Council Tax.

Please fill in this form if you, or someone living with you, is, or has recently been, on remand or in prison.

How to fill in this form

Please fill in the form using **black ink**. Answer **Yes** or **No** questions by putting a tick ✓ in the relevant box. If you find it difficult to fill in the form, please telephone us on 0300 304 8000.

We must see evidence of the person's detention. This could be a letter from a probation officer, court officer, health worker, prison official or other official who knows about the case. They must confirm where the person is detained, the reasons why, the start date of the detention and the date of release (or likely date of release). **We cannot process your claim without this proof.**

When you have filled in the form **make sure you read and sign the declaration in Part B.**
