Gladman are in general support of the Policy Intentions for the Neighbourhood Plan. Further specific comments and considerations are highlighted below.

Policy H1 states that residential developments of 10 of more net additional dwellings will be required to provide at least 10% of the housing to directly meet the needs of older residents and goes on to specify that this accommodation will need to be single storey.

Whilst recognising the issue of an ageing population is very much of concern to the steering group, in its current form and indeed as stated in our previous representation during the Regulation 14 and Regulation 16 Consultation, the policy would apply to all residential developments across the neighbourhood plan area. Gladman are pleased to note that compliance with this policy is subject to viability and a demonstrated need, we do however consider that the policy is far too prescriptive in requiring housing for older people to be provided at specific storey heights. This is not a reasonable requirement of any development nor is it reflective of the market realities of providing accommodation for older people, which is generally provided at a higher density than that suggested by the policy. This is considered to be an unsubstantiated design requirement which does not conform with the NPPF (see, for instance, paragraph 60).

Gladman recognises the Governments ongoing commitment to neighbourhood planning and the role that such Plans have as a tool for local people to shape the development of their local community. However, it is clear from national guidance that the WMCFNP must be consistent with national planning policy and the need to take account of up-to-date housing needs evidence and the direction contained in any emerging Local Plan.
